## PROCEDURE TO TRANSACT

- 1 - Letter Of Intent (LOI) from buyer to iCommodity sent by e-mail only.
- 2 - Confirmation of availability from iCommodity to be sent to the buyer by e-mail only.
- 3 - Issuing of a Commercial Invoice to confirm the quantity and price – Buyer can submit to their bank to issue a Letter of Credit (L/C).
- 4 - Opening a Confirmed L/C operative, confirmed MT 700 on sight of the full Commercial Invoice (By Buyer's Bank).

A revolving L/C is acceptable if the buyer's bank guarantees the full amount of the commercial invoice on the same L/C MT700 confirmed at sight and operative and the amount of the L/C is 25% of the total amount of the commercial invoice.

5 - Sales Contracts signed and stamped by both Seller and the Buyer. Delivery of the material will commence according to the terms on the L/C under the guarantee from the bank.

## BROKER RIGHTS

- 1 - The L/C shall be open to in the name of iCommodity or in the name of entities so instructed by iCommodity in order to preserve the rights of brokers and the opener of commercial invoices.
- 2 - An immediate letter of commitment shall be made after issuing the Commercial Invoice to the commercial invoice issuer (Broker).

The letter of commitment guarantees the broker commission. Broker commissions will be paid once the confirmed Letter of Credit (L/C) becomes operative and confirmation is sent by Swift system to our bank.

## PAYMENT METHODS

Only one payment method is acceptable:

Operative, Confirmed Letter of credit (L/C) MT 700 at sight.

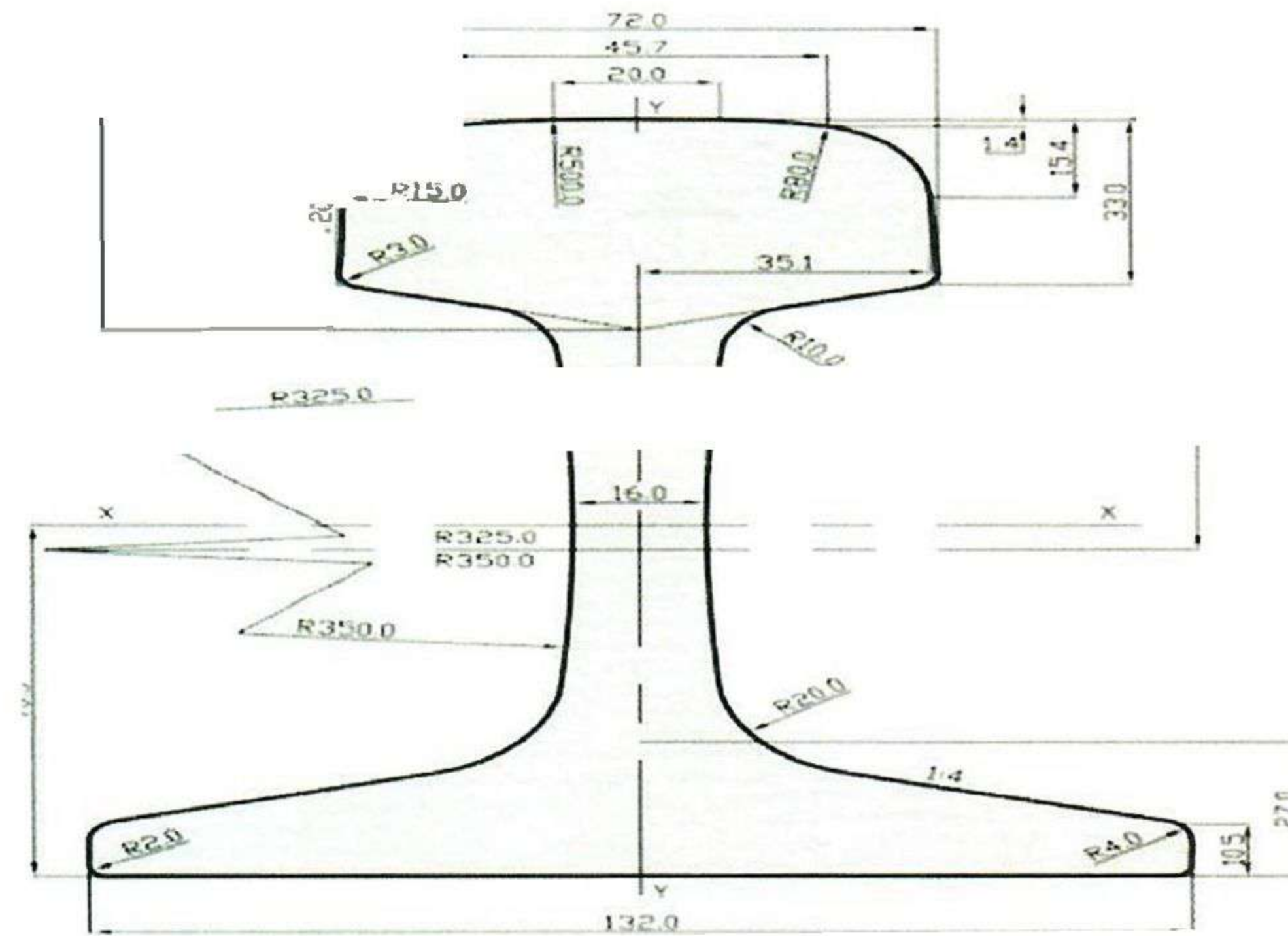
The administrative expenses of the bank shall be calculated on our account after opening the Credit and accepting it.

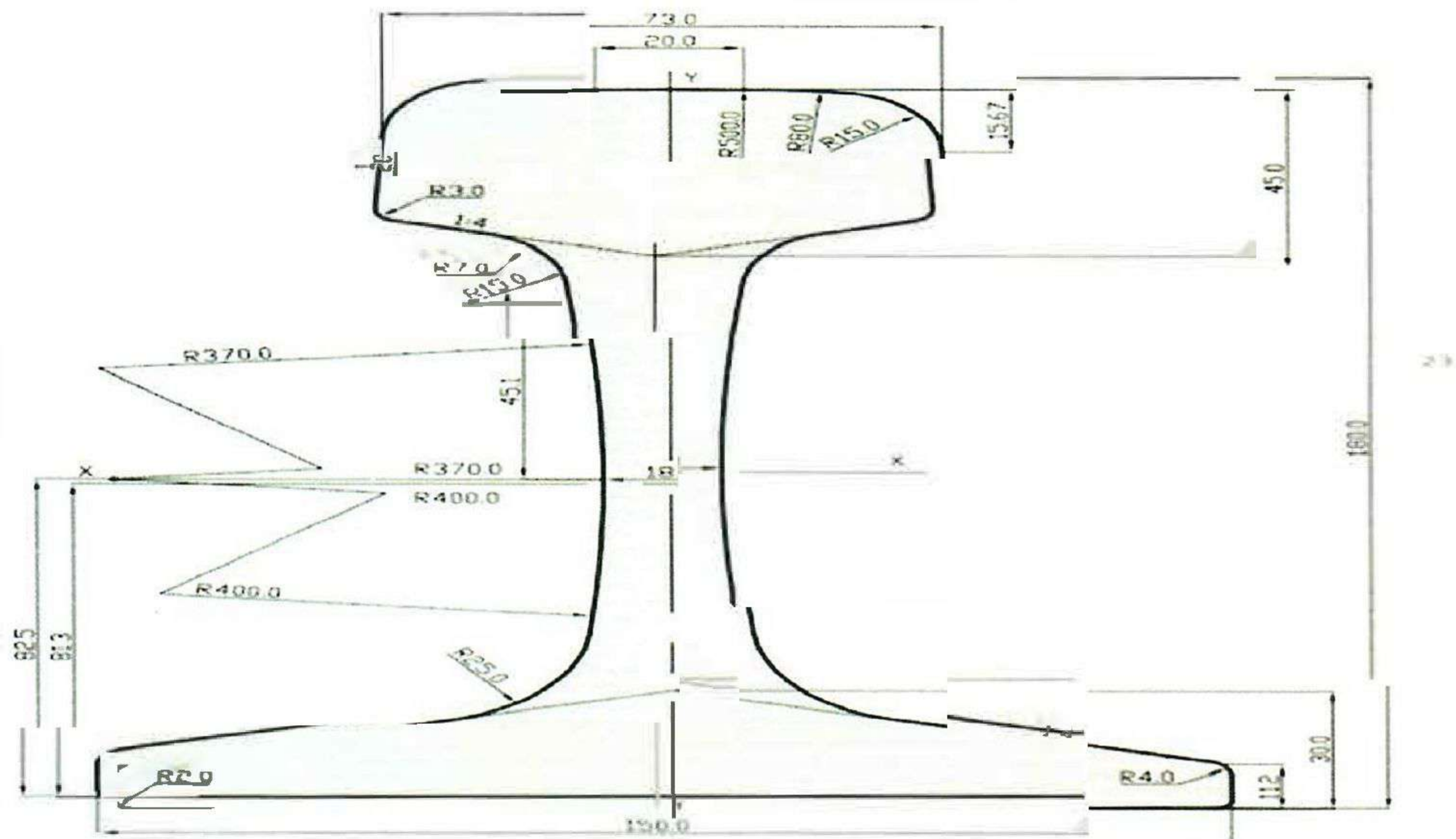
